Directing Your Gift:

Cash

- **Tribute Gifts:** Your cash donation can be given in honor of a friend or loved one.
- **General Donation:** Unrestricted gifts may be applied toward the general operating costs of the library or diverted to areas of greatest need. These funds are often used to support programs, or to purchase hardware, books and other collection materials.

Life Insurance
